The City Council of the City of Center Point, Alabama met in Regular Session at the Center Point City Hall on Thursday, June 3, 2021, at 6:30 p.m.

Call to Order: The meeting was called to order at 6:30 p.m. by Council President D.M. Collins.

Education & Library- Councilwoman Sharon Jones, Chair- The Summer Reading program kicks off Saturday June 5th, all are invited to attend.

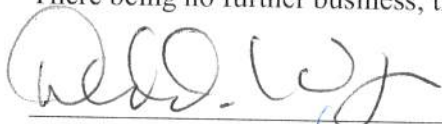
Finance Report: Councilwoman Ebonce Copeland, Chair-No report

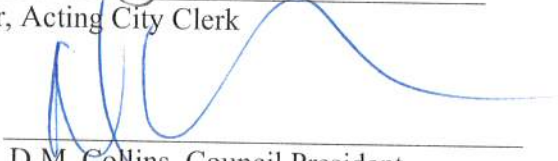
Adjournment:
